EXCEPT FOR 3M'S WARRANTY OF TITLE TO THE SYSTEM, THE FOLLOWING IS MADE IN LIEU OF ALL WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ANY IMPLIED WARRANTY ARISING OUT OF A COURSE OF DEALING OR OF PERFORMANCE, CUSTOM OR USAGE OF TRADE.

Except for RFID Tags ("Tags"), 3M warrants that the Hardware will be free of defects in material and manufacture for a period of 12 months after the completion of the installation of the Hardware in the case of Hardware that must be installed to obtain the benefit of its use or, for all other Hardware, the date the Hardware is shipped. Provided that the Hardware, other than Tags, have been properly installed, operated, and maintained according to 3M's instructions, and provided further that 3M receives notice of the alleged defect within 60 days after such defect was discovered, if 3M, in its sole discretion, determines that any Hardware, other than Tags, is defective in material and/or manufacture during the applicable warranty period, 3M's entire liability and 3M's sole obligation for breach of the foregoing warranty, will be, within a reasonable time after 3M receives written notification of the alleged defect and return to 3M of the alleged defective Hardware, other than Tags, at 3M's option, either: (i) repair of the Hardware, other than Tags, or (ii) replacement of the Hardware, other than Tags to the person who purchased the Hardware (other than Tags) directly from 3M.

3M warrants that each Tag will be free of defects in material and manufacture for the life of the article to which it was originally attached, even if such Tag is reprogrammed, however, the warranty does not apply to any Tag that is damaged in an attempt to remove it or after it is removed from the article to which it was originally attached. Provided that the Tags have been properly installed, operated, and maintained according to 3M's instructions, and provided further that 3M receives notice of the alleged defect within 60 days after such defect was discovered, 3M's entire liability and 3M's sole obligation for breach of the foregoing warranty will be, within a reasonable time after 3M receives notification of the defective Tag, replacement of any Tag determined by 3M to be defective.

These warranties shall not apply to any Product that has been damaged, repaired or modified by any person not authorized by 3M so that, in its sole judgment, the performance or reliability is adversely affected thereby, or which is subjected to abuse, mishandling, accident, misuse or neglect.

Any action for breach of this warranty must be commenced within one year after the breach occurs.

Statements or recommendations not contained herein shall have no force of effect unless in an agreement signed by an authorized representative of 3M. 3M may change the design or construction of its products without obligation in respect to products previously sold and delivered.

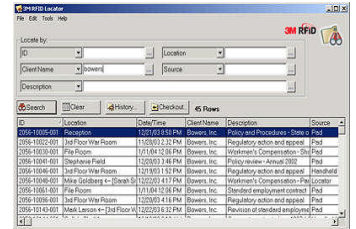
